Lucas gave an update on vessel movements which are still 95% coal exports, however PoN are planning for future diversification away from coal. Lucas presented on diversification plans. There has been an increase in grain exports, motor vehicle imports and wind turbine imports, A major project in the pipeline is the expansion of Mayfield berth to accommodate larger container ships, for import & export.
